BACKGROUND AND EXPERIENCE

Please briefly present the partner organisation.

Doctors of the World / Médecins du Monde – Greece (*MdM-Greece*) founded in 1990, is a medical humanitarian non governmental organization and is a member of Médecins Du Monde International Network which consists of 17 delegations (*Argentina, Belgium, Canada, France, Germany, Greece, Japan, Luxembourg, the Netherlands, Portugal, Spain, Sweden, Switzerland, United Kingdom, Turkey, Italy and the United States of America*). MdM-Greece is an independent NGO, whose modus operandi is characterized by its swift and targeted delivery of multisectoral assistance to vulnerable populations either in Greece or abroad. The guiding principle underlying MdM activities is that every human being has the right to humanitarian assistance, irrespective of their gender, race, sexual orientation, religion, ideology or political persuasion. MdM is, therefore, guided by the principles of neutrality and impartiality. Being neutral, however, does not preclude MdM from speaking out about human rights abuses witnessed in the field. Since the beginning of its operations, MdM identifies itself as an advocate on human rights thus retains the right "to bear witness", a concept thoroughly embedded in its first Articles of Association. MdM, strengthen by its diversity as a civil society movement, draws attention to human rights violations witnessed either publicly or by means of silent diplomacy.

MdM-Greece supports the vulnerable and the marginalized, the poor and the needy. We design and implement a variety of health as well as multi sectoral projects, spanning from emergency response to longer term objectives, such as harm reduction and communities' resilience. We promote tolerance and respect for diversity. We campaign for public health systemsthat are accessible to all and founded on the principles of equity and solidarity. We consider ourselves as agents of a wider social transformation process that leads to positive change.

MdM-Greece was awarded the European Citizen Prize 2022 for its response to the humanitarian crisis following Russia's invasion of Ukraine.

What are the activities and experience of the organisation?

Currently MdM runs various projects as a response to the increasing needs created by the recent socio economic and migratory crisis in Greece which include but are not limited to:

- Operation of 3 Open Polyclinics: 1 in Athens (*since 1997*), 1 in Piraeus (*since 2016*) and 1 in Thessaloniki (*since 2001*), while they also maintain a health office in Kavala (*since 2007*).
- Operation of 2 accommodation centers: One night shelter for homeless population with a capacity of 55 people and 1 mid term accommodation facility for women at risk, both in Athens.
- · Operation of a center for the empowerment of children and adolescents at risk of social exclusion in Athens
- Operation of medical mobile units offering medical services to people living in isolated and remote places all around Greece
- · Provision of medical services and psychosocial support to migrants and refugees stranded at the entry point of Lesvos
- · Operation of a harm reduction team for homeless drug users in Athens
- · Outreach support to homeless persons through street work activities in Athens and Piraeus
- · Social and medical services in remote islands that lack medical facilities (Chalki and Folegandros)
- · Provision of psychosocial support to the fire stricken population of Evia
- Emergency Covid 19 prevention and control activities countrywide in coordination with the public authorities (National Public Health Organization, Ministry of Health, Municipal agencies).
