

## ERASMUS+ Programme –Key Action 2: Strategic partnership IENE 8 - "EMPOWERING MIGRANT AND REFUGEE FAMILIES WITH PARENTING SKILLS"

## Project summary

The **IENE 8 project** addresses the complex issue of parenting skills among migrants and refugees and expand the existing Knowledge hub (KHub) (IENE6) for nurses, other health professionals and volunteers to enable them in empowering migrant and refugee parents. Focus is on helping refugee parents to better nurture, protect and educate their children under difficult circumstances. Outputs of the project include a curriculum and training for nurses and other health professionals and volunteers, bite-sized learning units for parents to better support of their children and family, and a collection of stories on migrant and refugee families.

2<sup>nd</sup> Transnational meeting in London

13<sup>th</sup>-14<sup>th</sup> May, 2019 The partners reviewed the minutes of the first meeting in Limassol and discussed the recent **GDPR**, EU data protection regulation. As a result, it was decided to add a disclaimer in the online KHub. Other changes were agreed around the KHub, mainly in order to differentiate **IENE 8 KHub** from IENE 6 one.

Based on the literature review (IO 1), the Curriculum Model (IO 2.1) and the Curriculum Content Map (IO 2.2) were presented and discussed (see below). Each partner chose to cover three out of overall 20 bite-sized learning units stemming from IO 2.2., for which a template was established. Crucially, it was also agreed to reduce to one day only (for a total of eight hours) the face-to-face part of the training which will be of 20 hours, with six hours pre- and post-training. Finally, template and timeline for the collection of stories was also established (IO 5). The consortium discussed and planned dissemination activities and financial issues. All deliverables were discussed and a timeline with agreed deadlines was established and circulated

covering each partner's tasks up to January 2020.







The first is the Curriculum Model (IO 2.1) which is informed by the original PTT model for Developing Cultural Competence and the PTT/IENE Model for Intercultural Education of Nurses in EU. The Conceptual PTT/IENE 8 European Model for the **Caregivers of Migrant and Refugee Families in** Transit provides a framework for a systematic approach to the building and delivery of the curriculum. The model included new important elements, such as Cultural aspects of parenting and of child-to-adult development. The second element is the Curriculum Content Map (IO 2.2) and it builds on four themes capturing the main challenges faced by refugee families and representing important risk factors for parental identity loss. These themes are: uprootedness, spatio-temporal uncertainty, trauma and abuses, and parental powerlessness.



The curriculum aims to inform an innovative training course to enable nurses and other health professionals and volunteers to provide support, knowledge, and skills on parenting and child-family health care needs. The curriculum is composed of **four broad learning areas** following the constructs of the PTT/IENE 8 model (see above): **Awareness, Sensitivity, Knowledge**,

**Competence**. Each unit comprises **five sub-units** for a total of **20** sub-units constituting the **Bite-sized learning units**: four subunits relevant to age related child-parent relationship, one sub-unit



for adults, both the parent and the carer. A total of twenty Bite-sized learning units are being developed, and they will translated into all the partners' language, **tested**, **delivered**, and made available on the project website, together with a **Training Guide** (**IO 3**). The units' topics span from Bonding, Boundaries, to Nutrition, Hygiene, and Selfcompassion and Mindfulness.
